We shall promote environmental awareness among our employees and students and encourage them to work in an environmentally responsible manner, train, educate and inform them about environmental issues that may affect their work.

#### 7. Improve Continually

Management at all levels of KEWI is responsible for ensuring that this policy is communicated and adhered to by all employees, students, suppliers and subcontractors, and that it is made available to interested members of the public.

We will set environmental targets, goals and objectives designed to improve our environmental performance.

We will review our progress and our environmental policy at least on an annual basis.

We will continuously seek opportunities to improve our adherence to set targets and goals.

We will periodically report progress to our stakeholders.

We shall maintain, review and report on clear environmental performance indicators including; monthly environmental inspections and audits, incident performance rates, training achievements and monthly environmental objectives.

We will Seek advice from an approved specialist environmental consultant as to what measures should be taken to prevent or reduce to an acceptable level the impact of activities taking place on the environment.

We shall develop a series of action plans to supplement each of our environmental policy objectives.

This Environmental Policy is applicable to KEWI and will be updated from time to time to reflect the emerging changes in the Institute.
